GREATER FLAGSTONE – PRIORITY DEVELOPMENT AREA  
NOTICE TO PERMANENTLY CLOSE A ROAD AND VEST THE LAND  
THAT COMPRISED THE CLOSED ROAD IN FEE SIMPLE**

Under the provisions of the *Economic Development Act 2012* (the Act) the Minister for Economic Development Queensland (MEDQ) may perform functions or exercise powers for a road that MEDQ considers necessary or desirable to perform its other functions in relation to a priority development area.

- Under section 124(1) of the Act, MEDQ considers it necessary to close a 1257m<sup>2</sup> footprint area of Road being part of Unnamed Road (described as Lot 60015 on SP356590) in the Greater Flagstone Priority Development Area on 2 September 2025 as shown on the below survey plan (the Land); and
- Pursuant to Section 125(1) of the Act MEDQ vests the Land on 16 September 2025 in MEDQ in fee simple being land that comprised a road under the *Land Act 1994* that has been closed under section 124 of the Act.
